

# Certificate of Financial Support

U.S. immigration regulations mandate that **F-1** and **J-1** students provide clear evidence of their ability to fully fund tuition, fees, medical insurance, and living expenses for themselves and any dependents for the entire duration of their studies. Students are required to demonstrate sufficient funding for the total cost of the first year of study and provide verifiable proof of reliable financial resources for all subsequent years. Submission of this Certificate of Financial Support is **required to issue the Form I-20**. See reverse side for more detailed instructions.

## Financial Information Instructions

### **Self-Support:**

If you are funding all or part of your educational expenses using personal savings or an approved loan, you must provide the name of your financial institution or lending agency and indicate the annual amount of funds you will use each year.

- For personal savings, submit an official bank statement issued on the institution's letterhead, verifying the amount in U.S. dollars. The statement must include transaction details for the previous 3 months and be dated within the last 90 days.
- For loans, submit an official document from the lending institution verifying the loan approval. The document must be on the lender's official letterhead with signature, specify the loan amount available for educational expenses, and be dated within the last 90 days.

### **Parents or Individual Sponsors:**

If your parents or other individuals are willing and able to sponsor all or part of your educational expenses, you should print the name of their bank and indicate the amount of funds they will make available to you each year. Submit an official bank statement from the sponsor's bank, on their letterhead with teller signature, verifying funds in U.S. dollars and showing transactions for the past 3 months. The statement must be dated within the last 90 days.

### **Government or Sponsoring Agency:**

If you will be sponsored by your government, an international organization or foundation, or another agency, you should print the name of the agency and indicate the amount of funds they will make available to you each year. Include a signed award letter on the organization's letterhead detailing the terms and amount of your sponsorship. The letter must specify:

- Whether tuition and fees are covered.
- Whether living expenses are covered and, if so, how much.
- The duration of the sponsorship.
- Whether additional support is provided for dependents (spouse or children), and if so, the amount.

### **Total:**

The combined total of each column must meet or exceed Truman's estimated annual expenses for each year of study.

Sponsors must complete and ***sign*** the sponsor section. **Incomplete submissions will not be accepted.**
